I AGREE in consideration for my participation in this Competition to the following:
 I AGREE that I choose to participate voluntarily in the Competition with my horse, as rider, driver, handler, vaulter, longeur, jockey, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware an acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").
 I AGREE to release the Federation and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Federation of the Competition.
 I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for and Harm caused by me or my horse at the Competition. I have read the Federation Rules about protective equipment, including GDR01 and BV114, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while ASKING that no protective equipment can guard against all injuries.
 I AGREE that "The Federation" and "Competition" as used above includes all of the officials, officers, directors, employees, agents, sponsors, exhibitors and affiliated organization. Affiliated organizations to include, but not limited to, NEHC, CHJA, CHSA, FWPHA, Merriall & Sterling League, RyeGate Show Services
 I AGREE that if I am injured at the competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USER accident/injury report form.
 I represent that I have the requisite training, coaching and abilities to safely compete in this competition.
